




1. No of vacancy for decentralized counseling: 13 (Thirteen).
2. Filled up applications are invited as per enclosed proforma for decentralized counseling for admission of student in 1st year Bachelor in Pharmacy course for the session 2017-18.
3. The candidates who have allotted / admitted in the participating Institute through e-counseling process, shall not be eligible for admission under decentralized counseling.
4. Admission shall be made based on:
 - i. Candidate with WBJEEM-2017 (Pharmacy Merit Rank);
 - ii. Candidate with JEE Main-2017 (GMR);
 - iii. Candidate with JELET-2017 rank (applicable for those who had sought lateral entry into 2nd year but could't get admission as lateral seats in 2nd year had got exhausted)
5. All these candidates shall have to meet the cut-off marks in qualifying examination (10+2) fulfilling AICTE norms.
6. Date of notification: 1st August, 2017.
7. Last date of receiving application: 12th August, 2017 upto 4.00 pm





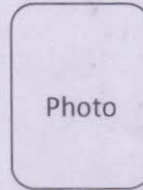
